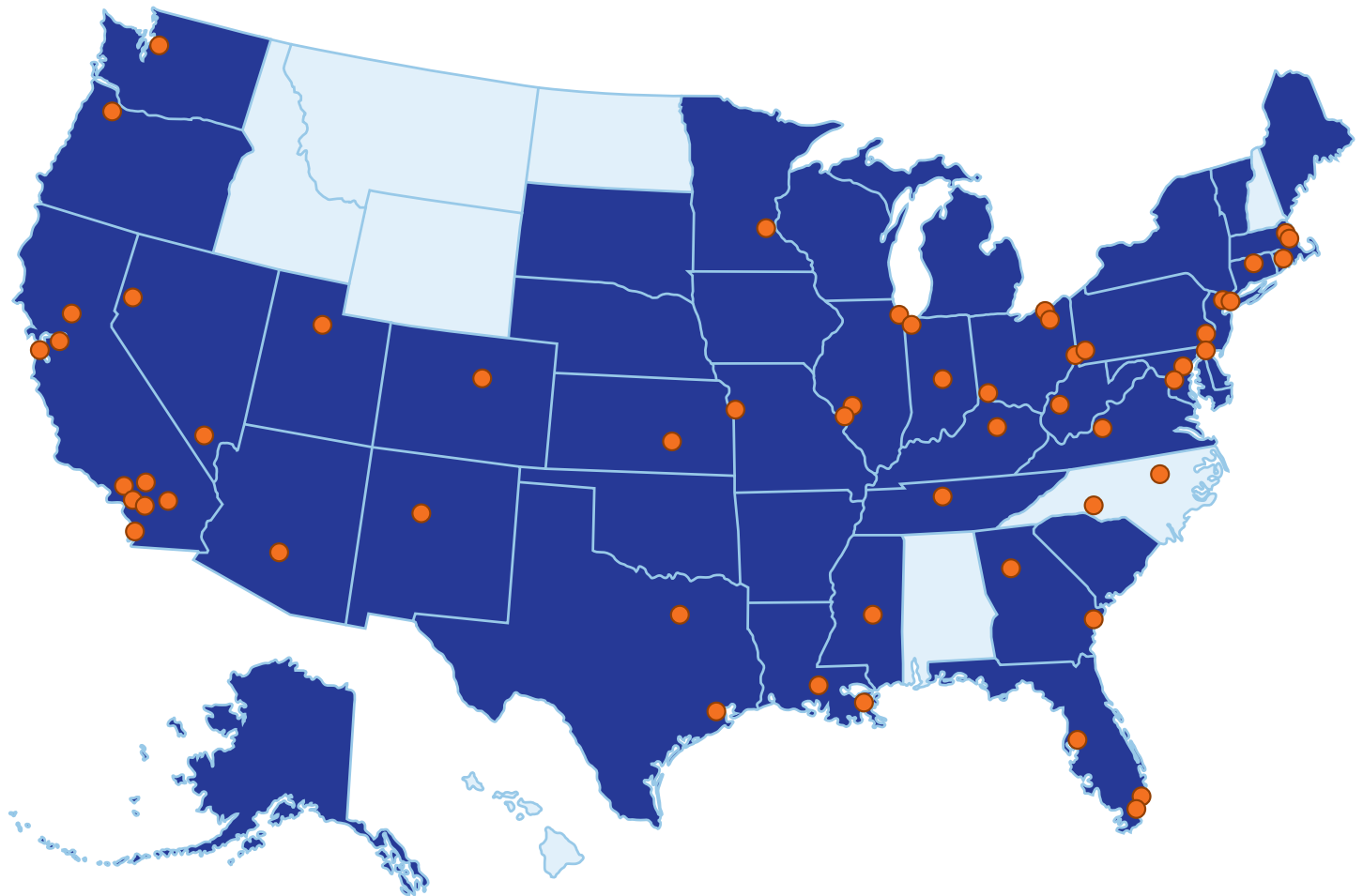

SAMPLING OF HIGH EXPOSURE TRIAL RESULTS

- Obtained a defense verdict for **UPS** in litigation in Cook County Circuit Court (IL) concerning a motor vehicle accident between a UPS tractor-trailer and another automobile that the automobile driver claimed led to his serious injuries.
- Obtained defense verdict for the **BNSF Railway Company** at trial in San Diego Superior Court (CA) in litigation concerning an incident in which a 23-year-old U.S. Navy sailor flew off his motorcycle allegedly due to potholes and unsafe railroad tracks, leading to his death. Jurors deliberated for 30 minutes following a two-week trial before determining that our client bore no responsibility for the sailor's death.
- Secured a defense verdict following a five-week fully remote trial with 23 witnesses and nearly 300 exhibits in a complex commercial case involving multimillion-dollar claims alleging that defects in medication dispensing machines installed at long-term care facilities nationwide caused the plaintiff to go out of business.
- Obtained a unanimous verdict in Federal District Court for our client, the largest operator of recreational boating tours in Long Beach, CA, in a suit brought under the Federal Lanham Act and involving claims of false advertising.
- Represented the **Los Angeles Dodgers** in a high-profile lawsuit in Los Angeles Superior Court (CA) concerning the assault of a baseball fan in the parking lot of Dodgers Stadium; jury returned a partial plaintiff verdict for less than the amount we offered to settle.
- Represented the **construction manager for the job site in the 91st Street Crane Collapse Litigation**, a highly publicized lawsuit concerning a major construction accident in Manhattan. Following an eleven-month trial that featured more than 75 testifying witnesses, the jury found that our client was indemnified by the codefendant subcontractors and further agreed that our client was not negligent in the matter.
- Defended **Dexter Hysol Aerospace LLC** in a \$22 million lawsuit in Los Angeles Superior Court (CA) over the allegedly asbestos-related death of a former aerospace worker; the jury came to the conclusion that the death wasn't caused by asbestos after all and returned a full defense verdict.
- Obtained a defense verdict for **BraunAbility**, a manufacturer of wheelchair accessible vans, in contentious litigation in the State Court of Cherokee County (GA) alleging that a defectively designed van led to the death of an infant; the court agreed with our argument that the van had been modified.
- Defended apartment complex **Trump Village Section 3, Inc.** at trial in Kings County Supreme Court (NY) in litigation concerning a trip-and-fall that allegedly resulted in serious injury to the plaintiff. Due to the defendant having the same name as the President of the United States, several prospective jurors had strong views against our client, and as a result we spent an extensive amount of time obtaining promises from the jury to be fair. Nevertheless, we obtained a unanimous defense verdict in this case.
- Secured a unanimous defense verdict in litigation in Clark County District Court (NV) against nightclub **Blue Martini Las Vegas** in which the plaintiff claimed she tripped and fell on a two-step staircase as she was leaving, leading to several serious injuries. After little more than an hour of deliberations, the jury returned an 8-0 verdict against the plaintiff.
- Obtained unanimous defense verdict on behalf of a national home improvement company following an in-person jury trial and one hour of jury deliberations, in a matter in which the plaintiff, who was allegedly injured by a roll of carpet falling from a second story window, sought to hold our client negligent under a theory of vicarious liability for

the alleged actions of our client's subcontractor.

- Obtained a defense verdict after a two and a half week-long trial for a massage therapist and a high-end athletic club in an employment suit alleging sexual harassment, sexual assault and battery, and wrongful termination. The complete verdict in favor of our client came after only two and a half hours of jury deliberation.
- Secured a defense verdict in a multimillion-dollar claim alleging that medication dispensing machines installed at long-term care facilities nationwide were defective and caused the plaintiff to go out of business. The plaintiff claimed damages in the nine-figure range and the trial lasted five weeks, featuring 23 witnesses and nearly 300 exhibits.
- Represented **Greyhound** at trial in a highly publicized case involving a triple fatality.
