Petitioner shall serve this writ upon respondent and real party in interest forthwith.

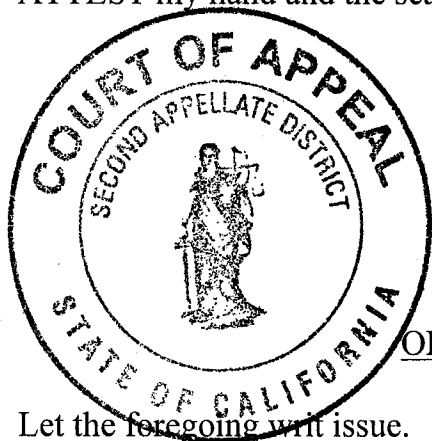
The written return to this writ shall be served and filed by December 5, 2011 .


